- Yearli Desktop is a desktop software filing program with an annual subscription fee of \$399. The cost to file each form to the IRS and send copies to employees is based on the number of forms you are filing.

ACA Reporting Overview

The Affordable Care Act requires employers to file annual information returns with the IRS and furnish statements to employees on healthcare plan coverage information beginning in 2016 (for reporting on calendar year 2015).

For calendar year 2015, employers with 50 or more full-time employees (including full-time equivalent employees) and all self-insured employers regardless of size must report healthcare coverage information to employees and the IRS. Reporting is mandatory for 2015.

The federal filing deadlines for Affordable Care Act reporting are consistent with W-2 & 1099 reporting. Form 1095-B or Form 1095-C, as applicable, must be provided to recipients/employees by January 31, similar to W-2 forms. This means that statements for 2015 must be provided no later than February 1, 2016 (because January 31, 2016 is a Sunday).
